#### 1. INTRODUCTION

#### 4. SHARING YOUR INFORMATION WITH SPONSORS

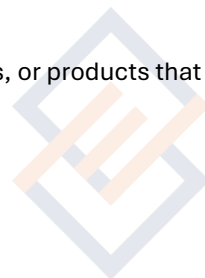
As part of our event, we may share your personal data with selected sponsors of the event. The information shared may include:

## 8. DATA RETENTION

We will retain your personal data only for as long as is necessary for the purposes set out in this Privacy Policy, or as required by law. After this period, we will securely delete or anonymize your data.

## 9. INTERNATIONAL DATA TRANSFERS

Your personal data may be transferred to and processed in countries outside of the European Economic Area (EEA). In such cases, we ensure that appropriate safeguards are in place to protect your data, in accordance with relevant data protection law requirements.
